

DIRECTIONS FOR USE:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

INDOORS: Use in non-living areas only (attics, basements, cellars, storage areas, garages, sheds and barns). Using gloves, lightly sprinkle granules directly from container at a rate of 0.25 lbs/15 Square Feet [Ft²] on areas to be protected. Repeat application after 30 days, if needed. 2.0 lbs will treat approximately 120 Square Feet [Ft²] [5.0 lbs will treat approximately 300 Square Feet (Ft²)] [10.0 lbs will treat approximately 600 Square Feet Square Feet (Ft²)].

OUTDOORS: Apply on sunny, dry days. Do not apply to foliage of shrubs or to ornamental, soft-bodied plants. Do not apply to food or feed crops. Using gloves, lightly sprinkle granules directly from container or using a spreader at a rate of 1 lb. per 40 Square Feet [Ft²]. Can be applied to lawns, garden paths and flowerbeds. To treat specific sites such as garbage bags, ornamental plants, trees or shrubs, spot treat ground around area to be protected, or if possible apply granules to ground as a border around entire area to be protected. Repeat application after 30 days, if needed. 2.0 lbs will treat approximately 80 Square Feet [Ft²] [5.0 lbs will treat approximately 200 Square Feet (Ft²)] [10.0 lbs will treat approximately 400 Square Feet Square Feet (Ft²)].
