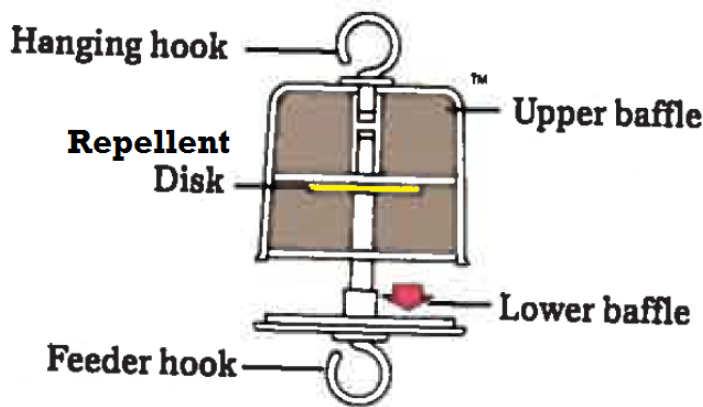
Ants\* are attracted to nectar. As ants\* forage they enter the ANTGUARD® PLUS device. Inside is a disk which repels ants\*. ANTGUARD® PLUS keeps rain off the disk and protects the nectar supply.

**To Install:** First clean your hummingbird/nectar feeder and add fresh nectar according to manufacturer's instructions. Next, remove ANTGUARD® PLUS from package and extend the lower baffle. Attach the ANTGUARD® PLUS below the hanging hook and above the hummingbird feeder (see photo on opposite panel of package.) ANTGUARD® PLUS starts to work immediately; all ant activity should stop within 24 hours. Under normal conditions, ANTGUARD® PLUS will give a full season of ant\* control.
