

USES

HOSPITAL SURFACE DISINFECTANT kills influenza A2 virus, deady Staphylococci, Streptococci, Salmonella, Trichophyton interdigitale (the athlete's foot fungus) and many other germs on bedsteads, bed springs, bed rails, bedside tables, bathroom basins, toilet seats, shower stalls, bathtubs, telephones, door handles, light switches, plumbing and plumbing fixtures, window blinds, empty hampers, waste receptacles, sills, walls, closets, soles of shoes for decontamination-places where germs may be a problem. The aerosol spray penetrates areas hard to reach with non-propelled liquid disinfectants.

PREVENTS MOLD AND MILDEW. Use in basements, closets, laundry rooms, summer cottages, boats, storage areas, showerstalls. Excellent for preventing mold and mildew on mattresses, pillows, shower curtains, painted surfaces, tiled walls, curtains and similar surfaces. For mildew control follow directions for disinfection. Application should be repeated once a week or when new growth appears on hard surfaces. Surfaces should be cleaned prior to application.

DIRECTIONS FOR USE:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

KILLS ODOR CAUSING ORGANISMS: When used as a surface disinfectant, this disinfectant kills odor causing germs in empty garbage cans, diaper pails, sick rooms, pet areas, and other inanimate hard surfaces.

TO DISINFECT: Hold can upright, 6" to 8" from pre-cleaned surface. Spray surface 2 to 3 seconds until covered with fine mist. Let dry on surface or allow to remain wet at least 10 minutes before wiping dry. Avoid spraying lacquered or shellacked surfaces.

TO DEODORIZE AIR: Hold can upright and spray into center of room 1 to 2 seconds. Spray in the air to eliminate cooking, bath, pool, and smoke odors.

PRECAUTIONARY STATEMENTS:

FLAMMABLE. Content under pressure. Do not puncture. Do not use near fire, sparks, or open flame. Exposure to temperatures above 130°F may cause bursting. Never throw container into fire or incinerator. Minimize inhalation. Avoid contact with food and food utensils. Avoid spraying in eyes. If eye contact occurs, flush with water.

STORAGE AND DISPOSAL:

Storage: Store in cool area away from heat or open flame.
Disposal: Securely wrap original container in several layers of newspaper and discard in trash.
