Diazinon AG500 EPA Registration Number 51036-71 Your submission dated June 17, 2001

The amendment referred to above, submitted in connection with registration under FIFRA section 3(c)(7)(a), is acceptable provided that you:

- 1. Submit and/or cite all data or other material required for registration/reregistration of your product under FIFRA section 3(c)(5) or FIFRA section 4 when the Agency requires all registrants of similar products to submit such data.
- 2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
- a. In the First Aid section, in the If Swallowed advice add "or convulsing" after "unconscious". Also, at the end of the First Aid section add the appropriate Note to Physician,
- b. In the Environmental Hazards text, delete the sentences pertaining to the deleted lawn use, i.e., delete the sentences beginning "Because of the migratory habits...", "On lawns...", and "Stop irrigation before...".
- c. Under the heading General Information, delete the sentence "Do not use on food crops grown in greenhouses." and revise the next sentence to read "Do not use in greenhouses, barns, or dwellings.".

- d. Under the heading Vegetable Crops, in the gallonage and PHI tables revise "Casabas" to "Casaba Melons" and revise "Crenshaws" to "Crenshaw Melons".
- e. As we discussed by telephone (and as you have done on your Self Certified labels), delete directions for use on the unsupported crop Sweet Potatoes.
- f. Also as we discussed by telephone, revise the heading "Insect Control on Ornamentals" to read "Insect Control on Ornamentals Grown Outdoors in Nurseries".
- 3. Submit three (3) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.

The Alternate Confidential Statement of Formula (CSF) dated May 30,2001, and which identifies your replacement diazinon source Manufacturing Use Product, is acceptable and has been added to this product's registration file.

Because of the migratory habits of Atlantic Coast waterfowl, do not apply this product to lawns in Nassau County, New York between November 1 and May 20. Do not exceed maximum permitted label rates. Rates above those recommended significantly increase potential hazards to birds and waterfowl. Avoid overlapping of sprays. On lawns, if waterfowl (ducks or geese) can be expected in the treated area after treatment (except spot treatment), apply a minimum of 1/4 inch of water immediately after applying this product. ## GENERAL INFORMATION

Diazinon AG500 is an emulsifiable solution which, when diluted with water according to the directions, is intended for the control of insect pests of agricultural crops and other plants. Do not use on food crops grown in greenhouses. Do not use in barns or dwellings. Do not use on livestock.

In the directions for use which follow, best control is obtained when application is made at first sign of pests. Application should be repeated only as directed to maintain control.

## DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Reformulation or repackaging of this product is prohibited.

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulation. Do not use water from irrigated or flooded cranberry beds for drinking purposes or to irrigate crops other than those appearing on EPA approved diazinon labels.

## AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment, notification to workers, and restricted-entry intervals. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard.

Do not enter or allow worker entry into treated areas during the restricted-entry interval (REI) of 24 hours.

#### CHEMIGATION

APPLICATION THROUGH AN IRRIGATION SYSTEM (CHEMIGATION) CRANBERRIES ONLY

Diazinon AG500 may be applied alone or in combination with other pesticides registered for application through sprinkler irrigation systems to cranberries. To insure compatibility, pour the products into a small container of water in the correct proportions. After thorough mixing, let stand for five minutes. If the combination remains mixed, or can be remixed readily, the mixture is compatible.

Do not apply this product through any type of irrigation system to other crops. For chemigation, apply this product to cranberries only through sprinkler irrigation systems. Do not apply this product to cranberries through any other type of irrigation system.

Crop injury, lack of effectiveness, or illegal pesticide residues in the crop can result from non-uniform distribution of treated water. If you have questions about calibration, you should contact State Extension Service specialists, equipment manufacturers or other experts.

Do not connect the irrigation system used for pesticide application to a public water system unless the pesticide label-prescribed safety devices for public water systems are in place. A person knowledgeable of the chemigation system and responsible for its operation, or under the supervision of the responsible person, shall shut the system down and make necessary adjustments, if the need arises.

Chemigation System Connected to Public Water Systems

- 1. Public water system means a system for the provision to the public of piped water for human consumption if such system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of the year.
- 2.Chemigation systems connected to public water systems must contain a functional, reduced-pressure zone, backflow preventer (RPZ), or the functional equivalent in the water supply line upstream from the point of pesticide introduction. As an option to the RPZ, the water from the public water system should be discharged into a reservoir tank prior to pesticide

introduction. There shall be a complete physical break (air gap) between the outlet end of the fill pipe and the top or overflow rim of the reservoir tank of at least twice the inside diameter of the fill pipe.

## Sprinkler Chemigation

- 1. The system must contain a functional check valve, a vacuum relief valve, and low pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow.
- 2. The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump.
- The pesticide injection pipeline must also contain 3. solenoid-operated functional, normally closed, on the intake side of the injection pump and system interlock to prevent fluid from connected to the being withdrawn from the supply tank when irrigation system is either automatically manually orshut down.
- 4. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops.
- 5. The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.
- 6. Systems must use a metering pump, such as a positive displacement injection pump (e.g. diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.
- 7. Do not apply when wind speed favors drift beyond the area intended for treatment.

## Operating Instructions

1. Determine the acreage to be treated by the sprinkler system.

- 2. Measure the appropriate amount of Diazinon AG500 needed to treat the acreage to be treated. Refer to the specific directions for use for cranberries for the application rate and the amount of water per acre.
- 3. Add the pre-measured Diazinon AG500 to the chemigation system supply tank and dilute with water if needed. Proper agitation is needed if Diazinon AG 500 is tank mixed with other pesticides registered for sprinkler chemigation application to cranberries.
- 4. Start the irrigation system and bring the system up to full pressure, making certain that all sprinkler heads are functioning properly.
- 5. Engage the chemigation injection or venturi system to add the diazinon to the irrigation lines.
- 6. Continue to run irrigation system for a few minutes after supply tank is empty to allow material in the irrigation lines to reach the sprinkler heads furthest from the chemigation injection point.

## Fruit and Nut Crops REI - 24 hours

Diazinon AG500 may be applied using ground or aerial application equipment as specified in the table below. This table also indicates the minimum amount of water that can be used for the various methods of application. The rate of Diazinon AG500 for aerial spray or concentrated spray applied by ground equipment is based on a dilute full cover spray applied to fruit or nut trees with conventional ground equipment at a rate of 300-400 gallons of water per acre. The specific amount of product to be used appears under the separate directions for use for each crop. If the "Rate" calls for 1 pint of Diazinon AG500 per 100 gallons of water, this amounts to 3-4 pts. of product per acre when applied to fruit trees at usual dilute ground spray volumes of 300-400 gallons of water per acre. In no case should the amount of product used per acre exceed the maximum amount per acre per application that is specified in the Timing/Special Directions for use for individual crops.

Spray when listed pests first appear. Try to spray underside of leaves and penetrate dense foliage. Repeat as necessary.
