- On page 11, the fourth sentence of the first paragraph now reads: "With concentrate sprayers apply 50 to 100 gallons of spray to 3 pints per acre."

Correct this sentence to read as it appeared on your previously submitted labeling, i.e., "With concentrate sprayers, apply 50 to 100 gallons of spray per acre. Citrus thrip: California and Arizona only: Use 2 1/2 to 3 pints per acre."

3. Submit your revised Confidential Statement of Formula (CSF) showing the following corrections:

- a. Complete column 11 to show the name and address of your supplier for the Technical Ethion used in the formulation of your product.
- b. A narrower range between the upper and lower certified limits should be provided for the solvent listed on your CSP. The upper certified limits should be lowered to 3.014 or lower. Please refer to 40 CFR 158.175 regarding certified limits.

4. Submit five (5) copies of your final printed labeling before you release the product for shipment. Refer to the A-79 enclosure for a further description of final printed labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
