The amendment referred to above, submitted in connection with registration under FIFRA section 3(c)(7)(a), is acceptable provided that you:

- 1. Submit and/or cite all data or other material required for registration/reregistration of your product under FIFRA section 3(c)(5) or FIFRA section 4 when the Agency requires all registrants of similar products to submit such data.
- 2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
  - a. In the First Aid section, in the last item of the If Swallowed advice, add "or convulsing" after "unconscious".
- b. The heading and associated text of the Agricultural Use Requirements should appear within an outline box.
- c. Under the heading Vegetable Crops, the heading and associated text of the Special Precautions to Reduce Risks to Birds should appear within an outline box.

- d. Under the heading Vegetable Crops, revise the sentence "Do not apply this product to food crops grown in greenhouses." to read "Do not apply this product in greenhouses.".
- e. Under the heading Field Crops, the heading and associated text of the Special Precautions to Reduce Risks to Birds should appear within an outline box.
- 3. Submit three (3) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.

The Alternate Confidential Statement of Formula (CSF) dated June 1, 2001, and which identifies your replacement diazinon source Manufacturing Use Product, is acceptable and has been added to this product's registration file.

#### AGRICULTURAL USE REQUIREMENTS

It contains requirements for training, decontamination, notification, and emergency assistance. Special Precautions To Reduce Risks To Birds

Birds feeding on treated areas may be killed. To reduce risks to birds:

- 1. Thoroughly incorporate this product into the soil during or immediately after application. Refer to the soil incorporation table that follows.
- Cover or incorporate spilled granules.

Diazinon 5G AG should be applied uniformly as directed for each crop. When a range of rates is given, use the higher rate for heavy infestations.

For application by ground equipment only. Do not apply this product to food crops grown in greenhouses.

NOTE: SOIL INCORPORATION - Unless directions under specific uses state otherwise, for control of pests listed below, Diazinon 5G AG should be incorporated into the soil during or immediately after application.

#### BEETS, RED (Table):

Cutworms - 38 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

Mole Crickets - 19 lbs. per acre. Broadcast and incorporate into plant beds or fields 1 to 2 days before sowing of seed or transplanting.

Wireworms - 57 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

#### BROCCOLI:

Root Maggots - 38 to 57 lbs. per acre. Broadcast and incorporate into the soil just before planting or transplanting. Cutworms - 38 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

Mole Crickets - 19 lbs. per acre. Broadcast and incorporate into plant beds or fields 1 to 2 days before sowing of seed or transplanting.

Wireworms - 57 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

#### BRUSSELS SPROUTS:

Root Maggots - 38 to 57 lbs. per acre. Broadcast and incorporate into the soil just before planting or transplanting. Cutworms - 38 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

Mole Crickets - 19 lbs. per acre. Broadcast and incorporate into plant beds or fields 1 to 2 days before sowing of seed or transplanting.

Wireworms - 57 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

#### CABBAGE:

Root Maggots - 38 to 57 lbs. per acre. Broadcast and incorporate into the soil just before planting or transplanting. Cutworms - 38 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

Mole Crickets - 19 lbs. per acre. Broadcast and incorporate into plant beds or fields 1 to 2 days before sowing of seed or transplanting.

Wireworms - 57 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

#### CARROTS:

Cutworms - 38 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

Mole Crickets - 19 lbs. per acre. Broadcast and incorporate into plant beds or fields 1 to 2 days before sowing of seed or transplanting.

Wireworms - 57 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

#### CAULIFLOWER:

Root Maggots - 38 to 57 lbs. per acre. Broadcast and incorporate into the soil just before planting or transplanting. Cutworms - 38 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

Mole Crickets - 19 lbs. per acre. Broadcast and incorporate into plant beds or fields 1 to 2 days before sowing of seed or transplanting.

Wireworms - 57 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

#### COLLARDS:

Cutworms - 38 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

Mole Crickets - 19 lbs. per acre. Broadcast and incorporate into plant beds or fields 1 to 2 days before sowing of seed or transplanting.

Wireworms - 57 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

#### ENDIVE (Escarole):

Cutworms - 38 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

Mole Crickets - 19 lbs. per acre. Broadcast and incorporate into plant beds or fields 1 to 2 days before sowing of seed or transplanting.

Wireworms - 57 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

#### GINSENG:

Cutworms, Climbing cutworms, Wireworms, White grubs - 38 to 76 lbs. per acre. In new beds, broadcast just before planting and incorporate into the top 4 to 8 inches of soil by tilling with hand-held or powered ground equipment.

Cutworms, Climbing cutworms, Wireworms, White grubs - 57 lbs. per acre. When soil insect damage appears in established beds, broadcast in the spring or late summer through early fall. Incorporate mechanically with 1/2 inch of irrigation.

NOTE: Do not apply more than once per growing season. Do not apply within 12 months of harvest.

#### KALE:

Cutworms - 38 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

Mole Crickets - 19 lbs. per acre. Broadcast and incorporate into plant beds or fields 1 to 2 days before sowing of seed or transplanting.

Wireworms - 57 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

#### LETTUCE:

Cutworms - 38 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

Mole Crickets - 19 lbs. per acre. Broadcast and incorporate into plant beds or fields 1 to 2 days before sowing of seed or transplanting.

Wireworms - 57 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

MELONS (Cantaloupes, Casabas, Crenshaws, Honeydew, Muskmelons, Persians and Hybrids of these) and WATERMELONS:

Cutworms - 38 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

Wireworms - 57 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

#### MUSTARD:

Mole Crickets - 19 lbs. per acre. Broadcast and incorporate into plant beds or fields 1 to 2 days before sowing of seed or transplanting.

#### ONIONS (Green and Bulb):

Onion Maggots - 57 lbs. per acre. Broadcast just before planting and incorporate into the top 3 to 4 inches of soil.

NOTE: Diazinon will not control organophosphate-resistant onion maggots.

Wireworms - 57 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

#### RADISHES:

Mole Crickets - 19 lbs. per acre. Broadcast and incorporate into plant beds or fields 1 to 2 days before sowing of seed or transplanting.

#### SPINACH:

Cutworms - 38 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

Wireworms - 57 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

#### SWEET CORN:

Cutworms - 38 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

Seed Corn Maggots - 38 to 76 lbs. per acre. Broadcast just before planting and incorporate into the soil 2 inches.

Wireworms - 57 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

#### TOMATOES:

Cutworms - 38 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

Mole Crickets - 19 lbs. per acre. Broadcast and incorporate into plant beds or fields 1 to 2 days before sowing of seed or transplanting.

Wireworms - 57 to 76 lbs. per acre. Broadcast and incorporate into the soil just before planting.

#### FIELD CROPS

#### Special Precautions To Reduce Risks To Birds

Birds feeding on treated areas may be killed. To reduce risks to birds:

- 1. Thoroughly incorporate this product into the soil during or immediately after application. Refer to the soil incorporation table that follows.
- 2. Collect or incorporate granules that are spilled during loading or are visible on soil surface in turn areas.

Diazinon 5G AG should be applied uniformly as directed for each crop.

#### SUGAR BEETS:

Sugar Beet Root Maggots - 19 to 38 lbs. per acre or 13.4 to 26.9 oz. per 1,000 linear ft. of row. Apply in a 5 to 7 inch band (based on 22" row spacing) incorporated 2 to 3 inches at planting.

Wireworms - 57 to 76 lbs. per acre. Broadcast and incorporate into the soil 4 to 8 inches just before planting.

NOTE: Do not apply more than 76 lbs. of Diazinon 5G AG per acre to the soil per season.
