angle. For control of chinch bugs, sod webworms (lawn moths), cutworms, earwigs, sowbugs (pillbugs), certain white grubs*, and Hyperodes (turfgrass) weevils** immediately after application sprinkle the turf with 1300 gallons of water per acre so as to wash the granules into the zone of insect infestation. Consult the following table to determine amounts of Chlorpyrifos 1/2% Bait and water needed for smaller sized areas. Repeat as necessary.

*To control certain white grubs (larvae of European chafer and Japanese beetle) use two to four times the amounts of Chlorpyrifos 1/2% Bait shown in the table, i.e. 10 to 20 pounds per 1,000 sq. ft. Apply the granules uniformly over the area treated followed immediately by thorough watering to wash the insecticide into the turf. For best results treat when grubs are young and actively feeding near the soil surface, usually during late July and August. Consult your local Agricultural Extension Service specialist for proper time to treat in your area.

**To control Hyperodes (turfgrass) weevils use twice the rate of Chlorpyrifos 1/2% Bait shown in the table. Treat suspected problem areas in mid-April and again in mid-May. Consult your local Agricultural Extension Service specialist for best time to treat in your area.
