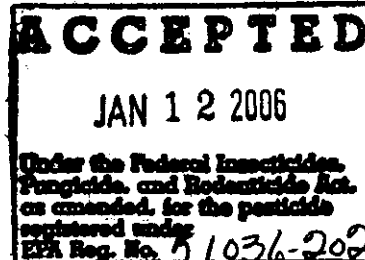

COTTON:

Apply 5 lbs. PGR-IV GRANULE per acre in-furrow at planting time.

CORN (FIELD & SWEET):

Apply 10 lbs. PGR-IV GRANULE per acre in-furrow at planting time.

MILO:

Apply 10 lbs. PGR-IV GRANULE per acre in-furrow at planting time.

SOYBEANS:

Apply 10 lbs. PGR-IV GRANULE per acre in-furrow at planting time.

PEANUTS:

Apply 5 lbs. PGR-IV GRANULE per acre in-furrow at planting time.

LETTUCE, TURNIP:

Apply 10 lbs. PGR-IV GRANULE per acre in-furrow at planting time.
