#### WARNING

May be fatal if swallowed. Harmful if inhaled or absorbed through skin. Avoid contact with eyes, skin or clothing. Avoid breathing of vapor or spray mist. This product is a mild skin sensitizer. Repeated exposure may cause allergic reaction in sensitive individuals. Discontinue use and consult a Physician. Handle concentrate in ventilated area. When handling concentrate wear protective clothing such as long sleeved shirt, long-legged pants, hat, gloves and boots resistant petroleum solvent. Wash thoroughly with soap and water after handling and before eating or using tobacco. Remove contaminated clothing and wash before reuse.

NOTE TO PHYSICIAN: Chlorpyrifos is a reversible cholinesterase inhibitor. Atropine Sulfate is antidotal. Start treatment by giving 2 mg atropine by injection after cyanosis is overcome and repeat atropine at 0.4 to 4 mg every 15 minutes until atropinization is achieved (tachycardia, flushing, dry mouth and mydriasis). Oximes such as 2-PAM/protopam are also antidotal, but only in conjunction with atropine. Observe to insure symptoms do not recur as atropinization wears off. Morphine, theophyllins, phenothiazines and reserpine are probably contraindicated. This product also contains lightweight aromatic hydrocarbons that can produce a severe pneumonitis if aspirated during emesis. Consideration should be given to gastric lavage with endotracheal tube in place. Treatment is controlled removal of exposure followed by antidotal, symptomatic and supportive care.

# **ENVIRONMENTAL HAZARDS**

This pesticide is toxic to birds and wildlife, and extremely toxic to fish and aquatic organisms. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans, or public waters unless product is specifically identified and addressed in a NPDES permit. Do not discharge effluent containing this product into sewer systems without previously notifying in writing the sewage treatment plant authority. # STORAGE AND DISPOSAL

#### STORAGE:
