Cockroaches, Ants, Crickets and Firebrats: Apply as a coarse, low pressure spot spray, crack and crevice spray or with a paint brush to localized areas where these pests are found or normally occur including corners of rooms and closets, around television sets and radios, along and behind baseboards, around and under sinks, dishwashers, washing machines, refrigerators, stoves and cabinets, areas where plumbing enters or leaves the room, or other areas inhabited by these pests.
