Dear Mr. Washburn:

The labeling amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, As Amended (FIFRA), is acceptable, provided that you submit two copies of your final printed label incorporating the following correction before you release the product for shipment.

Clarify the maximum seasonal application rate restriction so that it is clear as to the maximum amount of active ingredient and amount of formulated product to be applied per acre; i.e.


Do not apply more than 1.66 lbs/acre (1.5 lbs a.i./acre) of Acephate 90SP per season.

If this condition is not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product bearing the amended label constitutes acceptance of this condition.

At your next label printing, or within one year, whichever comes first, you must incorporate this supplemental labeling into the main product labeling. A stamped copy of the label is enclosed for your records

Additional label corrections may be needed pending review and evaluation of the required responses to the Interim Reregistration Eligibility Decision and accompanying Data Call In which were mailed to all acephate registrants.
