SUBJECT: Thiophanate Methyl 70W WSB,

Your label amendment submitted September 30, 2002 to add canola.

The supplemental label for canola, referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended is acceptable provided you make the following changes:

- Change "Product Bulletin" to "Supplemental Label" and change "Read the entire label for Thiophanate Methyl 70W WSB before proceeding with the use directions contained in this bulletin" to "Read the entire label for Thiophanate Methyl 70W WSB before proceeding with the use directions contained in this supplemental label".
- Immediately following the section discussed in the first bullet, change "Thiophanate-methyl Fungicide" to "Fungicide".
- Delete the company address and phone numbers at the bottom of the page since the labeling must bear the address which is on record with the Agency (which in this case is the address at the top of this letter).
- In the "Remarks" column of the application rate table, delete "T-Methyl 70W WSB" and replace it with the correct product name, Thiophanate Methyl 70W WSB or use the phrase "of product."

This label change must be incorporated into your main label at the next printing or by November 1, 2004, whichever comes first.
