

 - a. **List** the specific uses of the end-use products, Triclopyr TEA MUP and Triclopyr BEE manufacturing-use product, that the Triclopyr Acid Technical MUP will be formulated into or,
 - b. **Add** a statement to this section of the label which restricts the use of the MUP, Triclopyr Acid Technical, for formulation **ONLY** into the Triclopyr TEA MUP and Triclopyr BEE manufacturing-use products.
4. Add the word **"PESTICIDE"** to the **STORAGE AND DISPOSAL** section of the label so that the first subheading begins with: **"PESTICIDE STORAGE"** rather than **"STORAGE."**
5. As a condition of registration, you must comply with the letter dated June 13, 2000 from James Jones, Director of the Registration Division to C.E. Formby, President and CEO of Micro Flo Company.
6. Submit three (3) copies of the revised final printed label.
