STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

<u>PESTICIDE STORAGE</u>: Keep this product dry in a tightly closed container, when not in use. Store in a cool, dry, well-ventilated area away from heat or open flames. In case of a spill or leaking container, prevent personnel exposure by wearing approved personal protective equipment such as impervious clothing, gloves & an organic vapor respirator. Stop the leak and recover the material by placing liquid into another container for recovery or disposal by a method approved by state or local authorities.

Stand the container on its end and tip it back and forth several times. Turn the container onto its other end and tip it back and forth several times. Empty the rinsate into formulation equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling if available or reconditioning if appropriate or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.
