Convenient, easy to use pump spray allows quick and thorough application to skin, hair, and clothing for maximum protection.

Read and follow all directions and precautions on this product label. Hold container upright about 4 to 6 inches from skin or clothing. Do not use as a space spray. Do not spray in enclosed areas. Spray and spread evenly with your hand to moisten all exposed skin. Use just enough repellent to cover exposed skin and/or clothing. Avoid over-application of this product. Frequent reapplication and saturation of clothing are unnecessary for effectiveness. To apply to face, spray palms of hand and apply to cover face. Apply sparingly around ears. Do not apply to eyes and mouth and do not apply to the hands of young children. Do not allow children to handle this product. When using on children, apply to your own hands and then put it on the child. Do not apply over cuts, wounds, or irritated skin. Do not spray directly on the face.
