NOTE: MORPEL® Repellent 326 may crystallize from exposure to temperatures below 70°F during shipment or storage. The drum may be filled with crystals or a layer of darker liquid over crystals. Warm drum gently to relquify. Agitation and probing during warming will speed liquification. Do not heat above 120°F. Do not hold at elevated temperatures any longer than necessary. Agitate drum thoroughly before use. Mix well in drum before sampling and each use.
