

DIRECTIONS FOR USE: It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Remove inner package containing tablets from outer plastic bag. Place the package, holes down and tablets facing up, into drain pan at a point as far from the drain hole as possible. Be sure that the single tablet at one end of the package is farthest from the drain hole. In extremely dirty pans it would be helpful to clean the pan before placing the package. The dirt might block the opening in the bottom of the package and inhibit metering of the ACTABS®. Use one package for each 2 square feet of drain pan area.

PRECAUTIONARY STATEMENTS:

HAZARDS TO HUMANS AND DOMESTIC ANIMALS.

DANGER: Causes skin and eye irritation. Do not get in eyes, on skin or on clothing. In case of contact, flush with plenty of water. Harmful if swallowed. Avoid contact with food.

Statement of Practical Treatment

If swallowed: Promptly give milk and induce vomiting. Follow with more milk. Call a physician immediately.
