**DIRECTIONS FOR USE  
GENERAL CLASSIFICATION**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

ALGAE CIDE is used to control the growth of algae in swimming pools, exterior spas, whirlpools, hot tubs, and decorative fountains. For maximum effectiveness pools, spas, whirlpools, hot tubs, and decorative fountains containing heavy growth of algae should be cleaned prior to using ALGAE CIDE.

For pools having just visible algae growth add an initial dose of 50 to 77 fluid ounces of ALGAE CIDE per 10,000 gallons of water and remove settled algae debris by cleaning. For treatment of a freshly cleaned and filled pool add initially 27 to 50 fluid ounces of ALGAE CIDE per 10,000 gallons of water. Subsequent additions of 9 to 18 fluid ounces of ALGAE CIDE per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, or decorative fountains having just visible algae growth require an initial dose of 5 to 8 fluid ounces of ALGAE CIDE per 1,000 gallons of water. For treatment of a freshly cleaned and filled spa, whirlpool, hot tub, or decorative fountain, add initially 3 to 5 fluid ounces of ALGAE CIDE per 1,000 gallons of water. Subsequent additions of 1 to 2 fluid ounces of ALGAE CIDE should be made every 5 to 7 days after initial treatment for maintenance.

ALGAE CIDE is compatible with those chemicals normally used to treat pools and spas and is effective at both acid and alkaline pH. ALGAE CIDE can be used in pools and spas treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, do not mix ALGAE CIDE with concentrated dry or liquid chlorine products.

**STORAGE & DISPOSAL:** Keep container closed when not in use. Do not contaminate water, food, or feed by storage, disposal or cleaning of equipment. Rinsate that cannot be used or reprocessed should be disposed of in a landfill approved for pesticides or buried in a safe place away from water supplies. Open dumping is prohibited.

**METAL CONTAINERS:** Triple rinse and offer for recycling, reconditioning, or disposal in an approved landfill or bury in a safe place.

**PLASTIC CONTAINERS:** Do not reuse empty container. Triple rinse and incinerate or dispose of in an approved landfill or bury in safe place.
