CAUTION: Harmful if swallowed. Avoid breathing vapors. Avoid contact with skin, eyes, or clothing.

FIRST AID: If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution, or, if those are not available, drink large quantities of water. Avoid alcohol. Call a physician immediately.

ENVIRONMENTAL HAZARDS: This pesticide is toxic to fish. Keep out of lakes, streams, or ponds. Permits may be required for discharges containing this pesticide into lakes, streams, ponds, or public water. For guidance, contact the regional office of the Environmental Protection Agency.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

AQUACIDE 3511 is used to control bacteria, algae, and fungi in recirculating commercial and industrial water systems. To insure its use, systems must be cleaned to remove slime, and other deposits. An initial slug addition of fluid ounces of AQUACIDE 3511 per 1000 gallons of water to provide a concentration of 48 parts per million of AQUACIDE 3511 in the system, is recommended. Repeat initial dosage of 1.53 fluid ounces of AQUACIDE 3511 per 1000 gallons of water.

120 parts per million of AQUACIDE 3511 should be employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions should be made in the sump. AQUACIDE 3511 is used to clean air-washing systems that maintain effective mist. To insure its use, systems should be cleaned to remove deposits. An initial slug dose of 24.7 fluid ounces of AQUACIDE 3511 per 1000 gallons of water should be employed each time. Repeat initial dosage until control is effected. 16.9 to 41.2 fluid ounces of AQUACIDE 3511 per 1000 gallons of water should be employed each time. Slug additions may be made to the collection trays of the airwash system.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not stack more than four drums high. Leaking or damaged drums for disposal. Spills should be absorbed in sawdust or sand and container closed when not in use.

PESTICIDE DISPOSAL: Waste resulting from the use of this product should be disposed of in a approved waste disposal facility.

CONTAINER DISPOSAL:
PLASTIC: Triple rinse (or equivalent). Then offer for recycling or for secondary landfill, by incineration, or, if allowed by state and local authorities.
METAL: Triple rinse (or equivalent). Then offer for recycling or for secondary landfill, or by other procedures approved by state and local authorities.
