An initial slug addition of 6.0 to 11.9 fluid ounces of AL 270 per 1000 gallons of water is recommended. Repeat initial dosage until control is evident.

Subsequent slug additions of 2.0 to 11.9 fluid ounces of AL 270 per 1000 gallons of water should be employed every 1 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the microbiological problem. Slug additions should be made in the sump of water cooling towers.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not expose to extreme temperatures. Do not stack more than five drums high. Drums should be opened in well-ventilated areas.
