


DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Slimicide C-195 is used for

recirculating cooling tower systems and industrial microbiological slime. Prior to the use of Slimicide C-195 industrial and/or commercial recirculating cooling towers should be cleaned to remove algal growth, microbiological slime, and other deposits. Initial slug addition of 4.5 to 6.8 fl. oz. of Slimicide C-195 per 1000 gal. of water to provide 40 to 60 ppm, based on total weight of water.

until control is evident. Make subsequent slug additions of Slimicide C-195 per 1000

ppm Slimicide C-195 every 2 to 3 days. Frequency of addition depends upon the relative amount of microbiological problem. Slug additions should be made to recirculating cooling tower systems.

Slimicide C-195 is used for cleaning of cooling towers which maintain effective mist-eliminating components. Cleaned to remove bacterial slime and other deposits. 13.6 fl. oz. of Slimicide C-195 per 1000 gallons of water is recommended.

Repeat initial dosage until control is evident. 7.9 to 13.6 fl. oz. of Slimicide C-195 per 1000 gallons of water should be employed every 1 to 5 days. Frequency of addition depends upon the relative amount of bleedoff. Slug additions may be made to the sump or the recirculating system.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not expose to extreme temperatures. Do not stack drums. Drums should be placed in overpack drums for disposal. Spills should be cleaned up and disposed of in a sanitary landfill. Keep container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes are acutely hazardous. If these wastes cannot be disposed of by other means, they must be incinerated at a high temperature. If these wastes cannot be incinerated, they must be disposed of in a sanitary landfill. For more information, contact your State Pesticide or Environmental Control Agency or your EPA Regional Office for guidance.

CONTAINER DISPOSAL:

PLASTIC: Triple rinse (or equivalent). Then offer for recycling or disposal in a sanitary landfill, by incineration, or, if allowed by state and local authorities, by other procedures approved by state and local authorities.

METAL: Triple rinse (or equivalent). Then offer for recycling or disposal in a sanitary landfill, or by other procedures approved by state and local authorities.
