

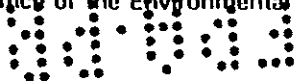

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

WC 630 is used to control bacteria and fungi in recirculating commercial and industrial water systems. To its use, systems must be cleaned to remove algal slime, and other deposits. An initial slug addition of _____ fluid ounces of WC 630 of water to provide a concentration of 16 to 4 WC 630, based on _____, in the system, is recommended. Repeat initial dosage Subsequent slug additions of 0.47 to 4 WC 630 per 1000 gallons of water employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions should be made in the sump of water. WC 630 is used to control bacteria in air-washing systems that maintain effective mist eliminators. To its use, systems should be cleaned to remove bacterial deposits. An initial slug dose of 7.1 to 11.9 WC 630 per 1000 gallons of water should be employed each 1 to 5 days. Repeat initial dosage until control is evident. Subsequent slug additions of 4.8 to 11.9 fluid ounces of WC 630 per 1000 gallons of water should be employed each 1 to 5 days. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions may be made to the collection trays of the airwash system.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not stack more than four drums high. Leaking or damaged drums should be disposed of. Spills should be absorbed in sawdust or sand and disposed of in a sanitary landfill. Container closed when not in use.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product must be disposed of in a sanitary landfill.

CONTAINER DISPOSAL:
