## PRECAUTIONARY STATEMENTS

### HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if swallowed or absorbed through the skin. Avoid contact with skin, eyes, or clothing. Do not smoke while using. Wash thoroughly after handling. Wash contaminated clothing before reuse. In case of contact, immediately flush exposed eyes or skin with plenty of water. Get medical attention if irritation persists. Avoid breathing spray mist or vapors. Keep children and pets off treated areas until spray has dried.

### STATEMENT OF PRACTICAL TREATMENT

If swallowed: Call Physician immediately. Drink 1 or 2 glasses of water and induce vomiting by sticking finger down back of throat.

If in Eyes: Flush eyes with plenty of water. Get medical attention if irritation persists.

If on Skin: Wash with soap and water, remove contaminated clothing.

NOTE TO PHYSICIAN: Active Ingredient is a cholinesterase inhibitor. Treat symptomatically. Atrophine by injection is antidotal.

### ENVIRONMENTAL HAZARDS

This product is toxic to fish, birds and other wildlife. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes. Do not apply where runoff is likely to occur.

### PHYSICAL OR CHEMICAL HAZARDS

Do not use or store near heat or an open flame.

### DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in any manner inconsistent with its labeling.

IN YARDS: To control insects as listed on front panel, apply 1 pint of spray concentrate in 78 gallons of water as a coarse, low pressure spray to cover 2600 sq.ft. or 1½ oz. of spray concentrate in 6 gallons of water covers 200 sq.ft. Spray may be applied with a garden hose sprayer. Retreat as necessary. Thoroughly water immediately after treatment to wash the insecticide into the treated area. For best results, the lawn should be moist at time of treatment. (See note below)

IN KENNELS AND DOG HOUSES: To control fleas and ticks, apply 10½ fl. oz. of spray concentrate in 1 gallon of water to resting areas, walls and floors. Old bedding of pet should be removed and replaced with clean, fresh bedding after treatment. (See note below)

NOTE: Remove pets before spraying. Do not treat pets with this product. Keep children and pets out of treated areas until spray has dried.

### STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry area away from heat or open flame.

DISPOSAL: Do not re-use container. Rinse thoroughly before discarding in trash. Securely wrap original container in several layers of newspaper and discard in trash.

Your submission dated March 14, 1985

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable provided the following revisions are made prior to release for shipment of stocks bearing the amended labeling:

1. The front panel of the label must bear the following:

KEEP OUT OF REACH OF CHILDREN

CAUTION

2. Revise your existing precautionary statements beginning, "Caution: Avoid prolonged breathing xxx etc", to read

PRECAUTIONARY STATEMENTS: HAZARDS TO HUMANS AND DOMESTIC ANIMALS:  
CAUTION: Avoid breathing of smoke. Avoid contact with skin and eyes.  
Wash hands thoroughly after handling. Harmful if swallowed.

3. A Statement of Practical Treatment must be added to the labeling. We suggest the following statement, however, if your toxicological data suggests otherwise, please submit a draft Statement of Practical Treatment for approval:

Statement of Practical Treatment

If swallowed - Call a physician or Poison Control Center immediately.  
Drink one or two glasses of water and induce vomiting  
by touching the back of throat with a finger. Do not  
induce vomiting or give anything by mouth to an  
unconscious or convulsing person.
