**STATEMENT OF PRACTICAL
TREATMENT**

IF SWALLOWED: Drink 1 or 2 glasses of water and induce vomiting by sticking finger down throat. Never give anything by mouth to an unconscious person. Call Physician.

IF ON SKIN: Wash with soap and water.

IF IN EYES: Flush with plenty of water. If irritation persists, see Physician.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

To control Fleas, Ticks and Lice on Dogs and Cats, dust powder liberally over the entire body. Rub dust into hair and around the feet, pads and between the toes so that they are well treated. Take care not to get the powder in animal's eyes, nose or mouth. Dust bedding, kennel and sleeping area regularly. Repeat as needed, but not more often than once weekly. Do not use on Pregnant Dogs.

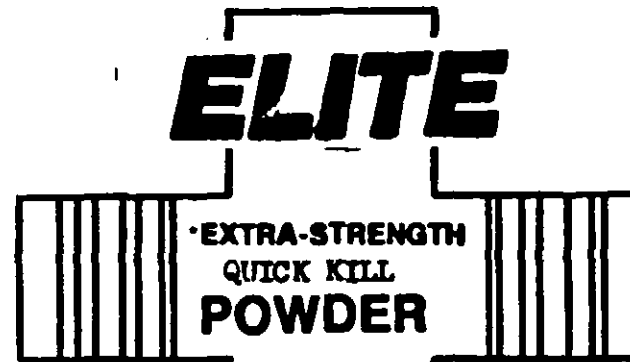
STORAGE AND DISPOSAL
