Subject: Label amendment-use as a wipe
Elite Flea & Tick Spray #5
EPA Registration Number 51793-26
Submission dated August 26, 1991

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Five copies of the finished product labeling must be submitted prior to releasing the product for shipment.

1. Expand the statement in the FOR USE AS A WIPE section to read "Rub into face around mouth, nose, and eyes, avoiding direct contact with the eyes."
2. Add the following statement to the DOGS & CATS subsection of the FOR USE AS A WIPE section: "For nursing puppies and kittens, rub only along back of animal."
3. The HORSES & FOALS subsection in the FOR USE AS A WIPE section should read as follows:

HORSES & FOALS: Avoid treatment of nursing foals.
First, brush animal to remove excess dirt and dust.....

SHAKE WELL BEFORE USING

HOLD BOTTLE IN UPRIGHT POSITION WHEN SPRAYING

CATS and DOGS: Cover animals eyes with hands and with a firm stroke to get a proper spray mist, spray head, ears and chest until damp. With finger tips, rub into face around mouth, nose, and eyes. Then spray neck, middle and hind quarters, finishing legs last. For best penetration of spray to the skin, direct spray against the natural lay of the hair. On long haired dogs rub your hand against the lay of the hair, spraying the ruffled hair directly behind the hand. Make sure spray thoroughly wets ticks. Repeat treatment as needed.

PUPPIES and KITTENS: Treat same as cats and dogs except nursing puppies and kittens. Spray only along back or on your fingertips and rub in with your fingertips.

PETS SLEEPING QUARTERS: Spray around baseboards, windows, door frames, wall cracks and local area of floors. If mosquitoes, gnats or flies are present, spray lightly into the air. Repeat as needed. The pet's bedding should be sprayed, making sure the area beneath the bedding is sprayed too. After the spray has dried, remove old bedding and replace with fresh bedding. Treat pets with a registered Flea and Tick Control product before allowing them to enter treated area.

HORSES: To control stable flies, horse flies, deer flies and face flies apply to face, legs, flanks, top line and other body areas commonly attacked by these flies. Repeat treatment as needed.

FOR USE AS A WIPE

DOGS & CATS: Cover pets eyes with hand. Wipe head, ears and chest until damp. Rub into face around mouth, nose, and eyes. For best penetration to the skin, direct wipe against the normal lay of the hair. Make sure wipe thoroughly wets ticks. Repeat treatment as necessary.

HORSES & FOALS: First, brush animal to remove excess dirt and dust. Rub wipe into face around mouth, nose, eyes, ears and areas where flies are often seen. Then wipe the neck, legs, shoulders, and shanks. Avoid using an excessive amount and do not wet skin. After application, brush thoroughly to bring out a bright sheen on the coat. Repeat as required.

STORAGE AND DISPOSAL

Storage: Store in a cool, dry area. Protect from freezing.

Disposal: Do not use empty container. Wrap container and put in trash collection.
