

Elite Room Fogger, EPA Reg. No. 51793-36
Submission dated August 27, 1993

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Three copies of the finished labeling must be submitted prior to releasing the product for shipment.

- 1) You must correct the source of the active ingredients in your Confidential Statement of Formula (CSF); the registration number 4618-8 does not exist. Perhaps, your intention was to depict Reg. No. 4816-8 which was referenced on the "old" CSF.
- 2) Revise the label statement, "All food processing surfaces should be covered during treatment or thoroughly cleaned before using" to read: "All food processing surfaces should be thoroughly cleaned with an effective cleaning compound followed by a potable water rinse before using".

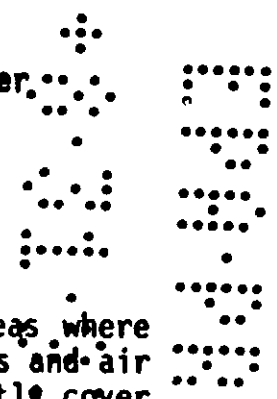
DIRECTIONS FOR USE

**It is a violation of Federal Law to use this product in a manner
inconsistent with its labeling.**

**One 6 ounce aerosol can treat up to 5,000 cubic feet.
One 12 ounce aerosol can treat up to 12,000 cubic feet.**

How To Use:

Open any cabinet doors and drawers to allow maximum kill in all areas where
insects can hide and breed. Close doors and windows and shut off fans and air
conditioning to maximize killing power of fog. Remove pets and tightly cover
or remove fish bowls or aquariums. Cover exposed foods, dishes or food



handling equipment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. Put out all lights including pilot lights.

Directions:

SHAKE WELL JUST BEFORE USING. Place can on level, raised surface such as stand or table with protective covering (i.e., newspaper) underneath to prevent possible marring of surface. With can at arms length, direct spray away from face. Depress tab until it clicks in locked position. Exit immediately. Keep area closed for 10 minutes. Do not remain in treated area and ventilate before reoccupying.

Use in food processing plants should be confined to time periods when the plant is not in operation. Foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. Avoid inhalation of spray mist. Avoid contact with skin or eyes.

PHYSICAL OR CHEMICAL HAZARDS

EXTREMELY FLAMMABLE. Do not use or store near fire, sparks or heated surfaces. Turn off pilot lights in gas appliances and unplug or turn off electrical equipment in the use area. After airing out phase is completed, relight pilot lights and reconnect electrical current. Do not smoke in the use area. Contents under pressure. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting. Incineration of container may cause explosion.

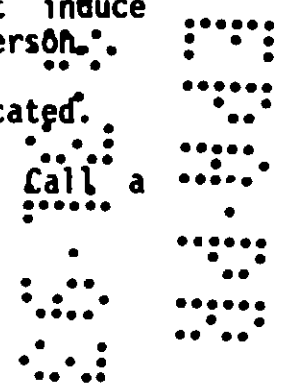

STATEMENT OF PRACTICAL TREATMENT
