Using a bulbous duster apply a small amount of material directly into cracks and crevices such as expansion joints between different elements of construction or between equipment bases and the floor, wall voids, motor housing, junction boxes or switch boxes, conduits or hollow equipment legs where cockroaches, ants, silverfish, spiders, boxelder-bugs, and ticks hide. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces.

APPLICATIONS OF THIS PRODUCT IN THE FOOD AREAS OF FOOD ESTABLISHMENTS, OTHER THAN AS A CRACK AND CREVICE TREATMENT, ARE NOT PERMITTED.

NON-FOOD AREAS:

Homes, institutions, hospitals, office buildings, hotels, motels, theaters, warehouses, truck trailers and railroad cars: To control crawling insects: cockroaches, silverfish, firebrats, spiders, boxelder bugs, ticks, lice, animal quarters, distribute at the rate of 2 ounces per 100 sq. ft. area. Apply a continuous visible film underneath and behind stairs, appliances. Treat on, around and behind moldings, shelving, baseboard openings, cracks, crevices, and other areas where insects hide. For infestations, apply behind cabinets and walls, in crawl spaces at rate of 16 ounces per 1000 square feet of surface area. Repeat treatment as necessary.

STORED PRODUCT PESTS:

To aid in the control of cadellies, cheese mites, cigarette beetles, carpet beetles, dark meal worms, drugstore beetles, grain mites, granary weevils, rice weevils, sawtoothed grain beetles and yellow meal worms, elevators and granaries. Clean up waste materials, dust, dirt, and thoroughly treat floors, walls and other surfaces in bins, storage areas. Apply into cracks and crevices and other difficult to reach areas where insects hide.

BEEES AND WASPS:

It is generally advisable to treat wasp and bee nests in the evening when they are less active and have returned to the nest. Using hand or power duster means, with extension tubes if necessary, thoroughly dust nest and surrounding areas where insects alight. Nests in wall voids can be treated with your ear against the wall. Drill a hole in the area, blow dust in, and ground wasps, dust entrance and surrounding areas. For best results, carefully one or two days after treatment to ensure complete kill, then destroy nest to prevent emergence of newly-hatched insects. If retreat is feasible, retreat the nest, if necessary. Do not use this product to treat nests of bees.

SEWER TREATMENTS:

American and Oriental cockroach infestations in sanitary sewers may be controlled by approximately 6 ounces per manhole. When treating sewer, per 200 feet of line should be treated. Treatments are made by removing cover and replacing with a disc of plywood bored to receive the usual from portable or truck mounted ventilating equipment. 6 ounces of insecticide is introduced into the ventilating air to be dispersed quickly and thoroughly.

BEDBUGS:

Take bed apart. Dust into joints and channels. If hollow, such as square, see that the interior of framework is well dusted. Mattresses should be lifted, folds, and edges. Picture frame moldings and all cracks and crevices should be treated.

DRYWOOD TERMITES

To protect against entrance, using an electric or hand operated rotary duster through an entry, e.g. crawl hole into attic and crawl space of 1 pound per 1000 square feet of floor area. All vents and blowers on roof should be closed. All wood surfaces should be covered. In case of long probe to locate galleries and drill holes to inject into the galleries. If heavy infestation has already developed, fumigation should be employed.

FLEAS: DOGS AND CATS

Liberally apply powder to the animal. Rubbing thoroughly to the skin and include the underbody, legs, feet and the base of the tail. Repeat treatment. Surfaces of kennels should be dusted at the rate of one ounce per 500 sq. ft. of infested lawns, basements, and crawl spaces should be dusted at the rate of 1000 square feet. Repeat as necessary.

SOW BUGS, PILLBUGS, GROUND BEETLES, EARWIGS, MILLIPEDES AND SCORPIONS:

Apply around doors and windows and other places where these pests enter. Treat baseboards, storage areas and other locations where these pests hide.

DISPOSAL

Do not reuse container. Wrap and put
