

DIRECTIONS FOR USE

Use one canister for each 2,500 cubic feet of unobstructed area. Example: 15.5 feet long by 20 feet wide by 8 feet high = 2,500 cubic feet. Use additional units for remote rooms or where free flow of the mist is not assured. Do not use in an area less than 1,000 cubic feet (12.5 feet by 10 feet by 8 feet).

PREPARATION: Cover exposed foods, dishes and food handling equipment. Cover or remove plastic, vinyl and wood surfaces/articles. Open cabinets and doors in areas being treated. 
