

HAZARDS TO HUMANS & DOMESTIC ANIMALS

### CAUTION

Harmful if swallowed. Avoid breathing of dust and contact with eyes, skin or clothing. Wash hands with soap and warm water after handling and before eating or smoking. For eyes flush with plenty of water. If irritation persists get medical attention. Do not contaminate feed, water or foodstuffs. Do not use in food serving areas while food is exposed. Food processing processing surfaces and utensils should be covered or thoroughly washed after treatment. Cover fish aquariums before use. Keep children and pets off treated carpet and upholstered furniture during treatment and until area is vacuumed.

### STATEMENT OF PRACTICAL TREATMENT

**If Swallowed:** Call a physician or Poison Control Center immediately. Induce vomiting by giving victim 1 or 2 glasses of water and touching back of throat with finger. Never give anything by mouth to an unconscious person.

**If in Eyes:** Flush eyes with plenty of water. Get medical attention if irritation persists.

**If on Skin:** Wash with soap and warm water.

Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on this label.

### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**DIRECTIONS:** Shake well before using. For use on carpets\*, hold upside down and shake powder evenly across surface. Brush lightly with a broom and allow powder to penetrate carpet fibers. Wait 60 minutes, then vacuum. For severe problems or where ticks are known to be hiding, wait 2 to 3 hours before vacuuming. If powder adheres to a spot, brush it out and vacuum immediately. Apply to dry surfaces only. Do not allow powder to become wet. For use on upholstery\*, remove all loose cushions. Sprinkle along creases in corners. Brush gently, wait 60 minutes, vacuum. Sprinkle along underside of furniture. Do not use on exposed fabric; may cause staining. Remove bag from vacuum cleaner. Wrap securely in several layers of newspaper and discard in trash.

\* Test on hidden surface of carpet or upholstery before cleaning. If texture or color is affected, do not use.

**Clean carpets after using this product.**

**Treat pets with a registered flea and tick control product prior to re-entry.**

## STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Store in a cool dry place out of reach of children. Do not re-use this container. Rinse thoroughly. Securely wrap in several layers of newspaper and discard in trash.
