Elite Aerosol Dog and Cat Repellent  
EPA Registration Number 51793-69  
Submission dated October 15, 1991

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Submit one copy of the final printed label prior to releasing the product for shipment.

1. It is acceptable to add the words "garbage cans" to the front panel listing of product use sites.
2. In the first sentence of the paragraph which follows the subheading "OUTDOORS", which appears in the DIRECTIONS FOR USE section, change the word "evergreen" to "evergreens".
3. Move the directions for "Garbage and Garbage Cans" so that they follow the "NOTE: This product is...aid." The "NOTE" pertains to the anti-urination claim to which the "OUTDOORS" directions apply. The garbage and garbage can claim is an anti-feeding claim.

Note that during Phase V of the reregistration process for the active ingredient methyl nonyl ketone, it is anticipated that product performance data will be required to support all claims for products containing this active ingredient.

**It is a violation of Federal Law to use this product in a  
manner inconsistent with its labeling.**

**SHAKE WELL BEFORE USING**

**Do not apply directly to foliage of shrubs or to ornamental,  
soft-bodied plants.**

**GENERAL:** For both indoor and outdoor situations, the most  
effective control for a pet is the sharply spoken word backed  
up with disciplinary action. This repellent product should  
be used in conjunction with training.

**INDOORS:** To break your pet of undesirable habits (such as  
sleeping on furniture, rugs, and other forbidden areas in  
your home): Spray the article of furniture, rugs, etc.,  
lightly with this product so that the area or object is  
slightly moistened.

Before spraying extensive areas of rugs, fabrics or plastics, test the effect of this product by first treating a small inconspicuous area. This product may stain or soften some fabrics or plastics. An alternate method to avoid possible damage is to spray a piece of cloth lightly and place it on the object or area in your home to be protected. Repeat daily, or as necessary, until undesirable habit is broken.

**OUTDOORS:** To prevent your pet, or stray animals, from soiling flower beds, areas of lawn, trees, shrubbery or evergreen: Spray the edges of flower beds, trunks of trees, the bases of shrubbery and evergreens, patches of lawn, etc., lightly every day, or every other day, with this product. Stray animals are frequently attracted to areas where urine or feces have been deposited. First, remove any droppings, then spray the spot with this masking odor. Re-apply as often as necessary until undesirable habits of your pet or stray animals are changed.

**Garbage and Garbage Cans:** Treat bags of garbage and garbage cans on all surfaces until wet. Allow to dry before handling. Re-apply as necessary.

**Note:** This product is not likely to break the established urination patterns of dogs unless used as a training aid.

#### **STORAGE AND DISPOSAL**

**Storage:** Store only in a cool, dry place inaccessible to children and pets.

**Disposal:** When empty, replace cap, securely wrap in newspaper and discard in trash. Do not incinerate or puncture.

#### **PRECAUTIONARY STATEMENTS**

##### **CAUTION**

##### **Hazards To Humans and Domestic Animals**

Harmful if swallowed or absorbed through the skin. Avoid contact with skin. Wash hands with soap and water after spraying.

Do not use in commercial food processing or preparation areas. In the home, all food processing surfaces and utensils should be covered during treatment. Cover exposed food. Do not apply to food crops.

### **PHYSICAL OR CHEMICAL HAZARDS**

**EXTREMELY FLAMMABLE.** Do not use or store near fire, sparks, or heated surfaces. Turn off pilot lights in gas appliances and unplug or turn off electrical equipment in the use area. After airing out phase is completed, re-light pilot lights and re-connect electrical current. Do not smoke in the use area. Contents under pressure. Do not puncture or incinerate container. Exposure to temperatures above 130F may cause bursting. Incineration of container may cause explosion.
