The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide Rodenticide Act, as amended, is acceptable provided that you make the labeling changes indicated below prior to release for shipment of product bearing the amended labeling.

Include the following statements under the Hazards to 1. Humans and Domestic Animals section before the last sentence:

Use rubber gloves (mitts) when applying. Do not use this or any other pesticide on sick, old, or debilitated animals.

Revise the Environmental Hazards statements as follows:

This product is toxic to fish and other aquatic organisms. Do not apply directly to any body of water. Do not contaminate water when disposing of equipment washwaters.

3. Under the Directions for Use, delete the statement "Repeat as necessary." and replace it with the following:

Dipping should not exceed 30 seconds. This product should not be used on animals more than once every seven days.

The reported flashpoint for this product is 142°F. Thus 4. the Physical Hazards statement should read "Do not use or
