Elite Dog and Cat Repellent Granules  
EPA Registration Number 51793-168  
Submission dated October 15, 1991

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Submit one copy of the final printed label prior to releasing the product for shipment.

1. It is acceptable to add the words "garbage cans" to the front panel listing of product use sites, since the use site has been accepted in the label text of the previously stamped accepted label. However, the statement "Keeps animals away from trees, shrubbery,..." should be revised to read "Keeps dogs and cats away from trees, shrubbery,..."
2. In the first sentence of the second paragraph which appears under the subheading "GENERAL" of the DIRECTIONS FOR USE section, change the word "evergreen" to "evergreens".
3. Move the directions for garbage can use so that they follow the "NOTE: This product is...aid." The "NOTE" pertains to the anti-urination claim to which the directions, which precede the directions for garbage cans, apply. Introduce the directions for garbage cans with the subheading "Garbage Cans." The garbage can claim is an anti-feeding claim rather than an anti-urination claim.

Note that during Phase V of the reregistration process for the active ingredient methyl nonyl ketone, it is anticipated that product performance data will be required to support all claims for products containing this active ingredient.

**DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Do not apply these granules directly to foliage of shrubs or to ornamental, soft-bodied plants. Do not apply on or near food crops.

**GENERAL:** The most effective control for a pet is the sharply spoken word backed up with disciplinary action. For most effective results on pets, this repellent product should be used in conjunction with training.

To prevent your pet, or stray animals, from soiling flower beds, areas of lawn, trees, shrubbery or evergreen: Apply

these granules by hand or with a fertilizer spreader to borders of flower beds; or to ground or grass around the bases of shrubs, trees, and evergreens; or to patches of lawn you wish to protect. Sprinkle enough to cover the treated area lightly (about 4 pounds per 1000 sq. ft.). Repeat applications until the undesirable animal habits are broken. Repeat applications after rains.

To protect garbage cans and rubbish containers from disturbance by dogs and cats, sprinkle the ground or floor around them liberally with granules. Repeat as necessary.

Stray animals are frequently attracted to areas where urine or feces have been deposited. First, remove any droppings, then apply these granules.

**NOTE:** This product is not likely to break the established urination patterns of dogs, unless used as a training aid.

#### **STORAGE AND DISPOSAL**

**Storage:** Store only in original container, in a dry place inaccessible to children and pets.

**Disposal:** Do not re-use container. Securely wrap in newspaper and discard in trash.
