3. The confidential statement of formula (CSF) is still not acceptable as submitted. As you were informed in our last letter, the CSF should reflect only the total amount of each active and inert ingredient, and not list the various steps involved in formulating the product. The formulation process should be described on a separate page. Please revise your CSF accordingly giving the total amount and percentage of each ingredient along with certified limits. For example, the total amount of the active ingredient carbaryl should be 19,398g in column 13(a), 0.51% in 13(b), 0.57% in 14(a) and 0.45% in 14(b). The revised CSF must be submitted within 30 days from the date of this letter.

4. Submit five copies of the revised labeling for this product before you release this product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
