It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Polyquat 30 is used to control algae, bacteria, and fungi in recirculating commercial and industrial water cooling towers. Prior to its use, systems must be cleaned to remove algat growth, microbiological slime, and other deposits. An initial slug addition of 1.90 to 4.75 fluid ounces of Polyquat 30 per 1000 gallons of water to provide a concentration of 16 to 40 parts per millio... of Polyquat 30, based on the total weight of water in the system, is recommended. Repeat initial dosage until control is evident.

Subsequent slug additions of 0.47 to 4.75 fluid ounces of Polyquat 30 per 1000 gallons of water (4 to 40 parts per million of Polyquat 30) should be employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the microbiological problem. Slug additions should be made in the sump of water cooling towers.

Polyquat 30 is used to control bacteria in industrial air-washing systems that maintain effective mist eliminating components. Prior to its use, systems should be cleaned to remove bacterial slime and other deposits. An initial slug dose of 7.1 to 11.9 fluid ounces of Polyquat 30 per 1000 gallons of water is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 4.8 to 11.9 fluid ounces of Polyquat 30 c or 1000 gallons of water should be employed each 1 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and severity of the bacterial problem. Slug additions may be made to the sump or to the water collection trays of the airwash system.

Polyquat 30 is used to inhibit the growth of bacteria in cutting fluids and oils employed as lubricants or coolants in the machining and processing of metals. "I is recommended that Polyquat 30 be added to the diluted cutting fluid at a concentratic of 0.02 to 0.20% based on total weight of the cutting fluid. Where added to the undiluted cutting fluid, Polyquat 30 should be added at a concentration which will provide 0.02 to 0.20% concentration when diluted with water for use. Treatment of the diluted cutting fluid should be repeated every four weeks as long as the cutting fluid is used. More frequent treatment may be required if excessive contamination occurs


