


DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Algaecide AL-101 is used to control algae and fungi in recirculating commercial and industrial cooling systems. To its use, systems must be cleaned to remove slime, and other deposits. An initial slug addition of fluid ounces of Algaecide AL-101 per 1000 gallons of water to provide a concentration of 32 Algaecide AL-101 parts per million, b in the system, is recommended. Repeat initial Subsequent slug additions of 1.0 Algaecide AL-101 per 1000 80 parts per million of Algaecide AL-101 employed every 2 to 5 days, or as needed. To upon the relative amount of bleedoff and the system. Slug additions should be made in the summer. Algaecide AL-101 is used in air-washing systems that maintain effective moisture. To its use, systems should be cleaned to remove deposits. An initial slug dose of 14.8 Algaecide AL-101 per 1000 gallons of water should be employed. Repeat initial dosage until control is achieved. Initial dosages of 10.1 to 24.7 fluid ounces of Algaecide AL-101 per 1000 gallons of water should be employed. Frequency of addition depends upon the relative severity of the bacterial problem. Slug additions may be made to collection trays of the airwash system.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. STORAGE: Do not stack more than four drums high. Leaking drums for disposal. Spills should be absorbed in sawdust or similar material. Container closed when not in use.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product should be disposed of by a registered or approved waste disposal facility.

CONTAINER DISPOSAL
