

GENERAL CLASSIFICATION

It is a violation of Federal law to use this product inconsistent with its labeling.

PWT Bioguard NM is used in recirculating commercial and industrial water cooling systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 5.1 PWT Bioguard NM per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 1.7 PWT Bioguard NM per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water cooling system.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. STORAGE: Do not expose to extreme temperatures. Do not store more than five drums high. Drums should be opened in well ventilated areas. Damaged drums should be placed in overpack drums and disposed of in a container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes are toxic. Disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal law.
