STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED: CALL A PHYSICIAN OR POISON CONTROL CENTER IMMEDIATELY. If less than ten (10) minutes have passed since the poison was taken, give 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Repeat until vomit fluid is clear. Have patient lie down in quiet, darkened room and keep him warm and quiet. Do not induce vomiting or give anything by mouth to an unconscious person.

IF INHALED: Remove victim to fresh air. Apply artificial respiration if indicated.

IF ON SKIN: Remove contaminated clothing and wash affected areas with soap and water.

IF IN EYES: Flush eyes with plenty of water. Get medical attention if irritation persists.

NOTE TO PHYSICIAN:

A Administer 100% OXYGEN by positive pressure to provide as much pulmonary gas exchange as possible, despite seizures.

B Administer ANTICONVULSANT DRUGS intravenously to control convulsions.

CAUTION It may be difficult or impossible to stop the seizure activity without stopping respiration. Be prepared to

maintain pulmonary ventilation mechanically. Tracheotomy may be necessary if seizures are prolonged.

Precautionary Statements: Hazards to Humans & Domestic Animals

DANGER Convulsive poison! Poisonous if swallowed. Do not breathe dust. Do not contaminate feed and foodstuffs. Keep away from children, pets, and domestic animals. Wash thoroughly with soap and water after handling and before eating or smoking. Clean clothing should be used daily.

Environmental Hazards: This product is toxic to fish, birds and other wildlife. Do not discharge into lakes, streams, ponds or public waters unless in accordance with a National Pollution Discharge Eliminating System permit. STORAGE AND DISPOSAL
