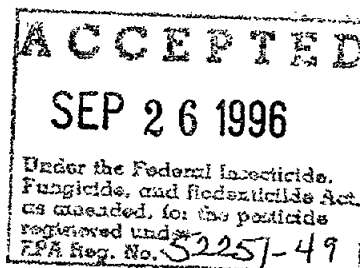

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

STATEMENT OF PRACTICAL TREATMENT

OR-CAL Slug & Snail Bait is a soil surface treatment for control of snails and slugs in citrus groves, orchards, berry crops, vegetable crops and gardens, ornamental gardens, seed grasses, dichondra and turfgrass lawns and in ornamental greenhouses. When applied as directed, OR-CAL Slug & Snail Bait will withstand rain and sprinkling and will offer protection to gardens and lawns for several weeks.

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulation.

READ ENTIRE LABEL. USE IN ACCORDANCE WITH PRECAUTIONARY STATEMENTS AND DIRECTIONS. DO NOT APPLY DIRECTLY ONTO PLANTS. Do not allow bait to contact edible portions of any food crop. This product may be injurious to Daylilies and Clematis. Do not use on these plants.

AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE) and restricted entry interval. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard. Do not enter or allow worker entry into treated areas during the restricted entry interval (REI) of 12 hours. USE PRECAUTIONS

Read entire label before using. Use only as a baiting treatment to be applied directly to the soil area beneath plants as listed on this label. Do not allow bait pellet to come in contact with parts of plant that may be used for food or feed purposes. The grower is responsible for residues on his crops, as well as for damages caused by drift from his property to that of others. Do not allow to drift to areas occupied by unprotected humans or beneficial animals or onto adjoining food, fiber, or pasture crops.

NOTE: Slug & Snail Bait should not be applied to dry soil. Applications should be made following an irrigation for best results. Apply any time of the day, but evening applications are preferred. Do not re-water for 48 hours after application.

APPLICATION RATE: For control of Snails and Slugs in the following areas, use 1 lb. to treat 1,100 to 1,500 sq. ft. of soil surface equivalent to 30 to 40 lbs. pellets per acre. Apply when first plant damage appears or is anticipated and repeat as needed for control.

FRUIT TREE CROPS: Apples, Apricots, Avocados, Cherries, Peaches, Pears, Citrus(Oranges, Lemons, Grapefruit, etc.)- Broadcast liberally under trees, around irrigation pipes, farm buildings and any other place where snails and slugs may congregate. Apply at the rate of 40 lbs. per acre.

BERRY CROPS: Blackberries, Boysenberries, Loganberries, Raspberries, Strawberries-For soil surface coverage, use up to 40 lbs. per acre.

VEGETABLE CROPS AND GARDENS: Artichoke, Asparagus, Beans, Beets, Blackeyed Peas, Broccoli, Brussels Sprouts, Cabbage, Cantaloupe, Cucumbers, Eggplant, Endive, Garlic, Ginseng, Horseradish, Kale, Kohlrabi, Leeks, Lettuce, Melons, Mustard Greens, Okra, Onions, Parsnips, Peas, Peppers, Pimentos, Potatoes, Pumpkins, Radishes, Rhubarb, Rutabagas, Salsify, Shallots, Spinach, Squash, Sweet Potatoes, Swiss Chard, Tomatoes, Turnips, Watermelons-Apply up to 30 to 40 lbs. per acre.

ORNAMENTAL PLANTS-ORNAMENTAL GARDENS, PLANTED BORDERS AND GROUND COVERS: Including Azaleas, Begonias, Camellias, Chrysanthemums, Daffodils, Daisies, Geraniums, Honeysuckle, Hydrangeas, Ice Plant, Impatiens, Iris, Marigolds, Pansies, Petunias, Rhododendron, Rose, Sweet Peas, Snapdragons, Spathiphyllum, Tulips-Water the infested area thoroughly before application. Broadcast or sprinkle this product evenly over the infested areas and along edges of flower beds adjacent to border or ground cover plants. Also apply on ground at base of fences and walls in shady, protected locations. One pound will cover up to 1,100 sq. ft. Do not re-water for 48 hours.

DICHONDRA AND/OR TURFGRASS LAWNS: Water infested area thoroughly before application. Broadcast this product directly on lawn or turf. Spread evenly. One pound will cover up to 1,500 sq ft. Do not re-water for 48 hours.

ORNAMENTAL GREENHOUSES: Water or irrigate greenhouse soil to be treated before application. Broadcast this product liberally around greenhouse, under benches in greenhouse and around plants; any place where snails and slugs might congregate. Do not apply directly to plants unless prior experience has shown the plant to be tolerant to this product. Most plants are tolerant to OR-CAL Slug & Snail Bait, however some slight tip burning has been noticed on extremely tender orchids. This product may be injurious to Daylilies and Clematis. One pound will cover up to 1,100 sq. ft. Do not re-water for 48 hours. NOTE: OR-CAL Slug & Snail Bait has proven to have a reasonable residual control, however for heavily infested greenhouses a second application is recommended 7 to 10 days following the first application to bring the house under control.

SEED GRASSES: Apply up to 40 lbs. per acre.

NON-AGRICULTURAL REQUIREMENTS

The requirements in this box apply to uses of the product that are NOT within the scope of the Worker Protection Standard, for agricultural pesticides 40 CFR Part 170. The WPS applies only when this product is used to produce agricultural plants on farms, forests, nurseries, or greenhouses.
