RM-55 MICROBIOCIDE is used in recirculating commercial and industrial water cooling systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 2.6

RM-55 MICROBIOCIDE per 1000 gallons is recommended. Repeat initial dosage until control is evident.

Subsequent slug additions of 0.85 to RM-55 MICROBIOCIDE per 1000 gallons

every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water cooling

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not expose to extreme temperatures. Store in a cool, dry place. Do not store in damaged drums should be placed in overpack drums. Do not be absorbed in sawdust or sand and disposed of in a container closed when not in use.
