It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

TeJ-Pool-30

in swimming pools, exterior spas, whirlpools, hot tubs, and decorative fountains. Heavy growth of algae should be cleaned prior to use.

For pools having just visible algae growth add TeJ - Pool-30 fluid ounces of TeJ - Pool-30 to remove settled algae debris by clearing. For hot tubs, add initially 12.8 to 23.5 fluid ounces per 10,000 gallons of water. Subsequent additions of TeJ-Pool-30 per 10,000 gallons should be made every 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, and decorative fountains require an initial dose of 2 to 4 fluid ounces per 1000 gallons of water. For treatment of hot tubs, or decorative fountains, add initially TeJ-Pool-30 per 1,000 gallons of 0.5 to 0.8 fluid ounces of TeJ-Pool-30 should be made every 5 to 7 days after initial treatment.

TeJ-Pool-30 is used to treat pools, spas, and decorative fountains with alkaline pH. TeJ-Pool-30 is used to treat decorative fountains treated with chlorine chemicals normally required. However, do not mix with concentrated dry or liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Containers should be placed in a plastic bag and stored with clear water. All pesticides should be kept away from food.

DISPOSAL: Do not reuse empty containers.
