It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

TeJ-Pool-60

In swimming pools, exterior spas, whirlpools, hot tubs, and hot tubs, minimum effectiveness pools, spas, whirlpools, hot tubs, and hot tubs with heavy growth of algae should be cleaned prior to use. For pools having just visible algae growth add a fluid ounces of TeJ-Pool-60 per 10,000 gallons of water. For pools with more settled algae debris by cleaning. For treatment of a hot tub or pool add initially 6 to 11 fluid ounces per 10,000 gallons of water. Subsequent additions of TeJ-Pool-60 per 10,000 gallons should be made every 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, and decorative fountains require an initial dose of 1 to 2 fluid ounces per 1000 gallons of water. For treatment of a hot tub, or decorative fountain, add initially TeJ-Pool-60 per 1,000 gallons of 0.2 to 0.4 fluid ounces of TeJ-Pool-60 should be made every 5 to 7 days after initial treatment.

TeJ-Pool-60 is commonly used to treat pools, spas, and decorative fountains with alkaline pH. TeJ-Pool-60

decorative fountains treated with chlorine chemicals normally required. However, do not mix with concentrated dry or liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Containers should be placed in a plastic bag and stored with clear water. All pesticides should be kept away from food.

DISPOSAL: Do not reuse empty containers.
