The label submitted with the application has been stamped "NOTIFICATION" and placed in our records.

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

It controls susceptible weeds by inhibiting weed seed germination and root development.

Do not graze or feed livestock forage cut from areas treated with this product. Do not apply aerially. Do not apply to golf course putting greens. Failure to follow the directions for use and precautions on this label may result in poor weed control, plant injury.

AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE) notification to workers, and restricted-entry intervals. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard (sod farms, commercial nurseries).

WEED-RESISTANCE MANAGEMENT

For resistance management, Turf Fertilizer with Barricade® 0.21 contains the active ingredient Prodiamine, a Group 3 Herbicide as determined by the mode of action (MOA) classification system of the Weed Science Society of America. Any weed population may contain or develop plants naturally resistant to Fertilizer with Turf Fertilizer with Barricade® 0.21 Group 3 herbicides. The resistant biotypes may dominate the weed population if these herbicides are used repeatedly in the same field. Appropriate resistance-management strategies should be followed. Continued effectiveness of this product depends on the successful implementation of a weed resistance management program.

To delay herbicide resistance users should take one or more of the following steps:

- Rotate the use of Turf Fertilizer with Barricade® 0.21 and other Group 3 herbicides within a growing season sequence, or among growing seasons with different herbicide groups that control the same weeds in a field.
- Adopt an integrated weed-management program for herbicide use that includes:
 - Scouting and uses historical information related to herbicide use and crop rotation, and
 - Consideration of tillage (or other mechanical control methods), and
 - Cultural (e.g., higher crop seeding rates), and
 - Precision fertilizer application method and timing to favor the crop and not the weeds), and
 - Biological (weed-competitive crops or varieties) and other management practices.
- Scout fields prior to application to identify the weed species present and their growth stage to determine if the intended application will be effective.
- Scout fields after herbicide application to monitor weed populations for early signs of resistance development. Indicators of possible herbicide resistance include:
 - Failure to control a weed species normally controlled by the herbicide at the dose applied, especially if control is achieved on adjacent weeds, or
 - A spreading patch of non-controlled plants of a particular weed species or,
 - Surviving plants mixed with controlled individuals of the same species.
- If resistance is suspected, prevent weed seed production in the affected area by using an alternative herbicide from a different group or by a mechanical method such as hoeing or tillage. Prevent movement of resistant weed seeds to other fields by cleaning harvesting and tillage equipment when moving between fields and planting clean seed.
- If a weed pest population continues to progress after treatment with this product, discontinue use and switch to another management strategy or herbicide with a different mode of action, if available.

BEST MANAGEMENT PRACTICES

Proactively develop and implement diversified weed control strategies to minimize selection for weed populations resistant to one or more herbicides. A diversified program may include the use of herbicides

with different modes of action along with cultural, mechanical, and/or biological practices. Best management practices include the following:

- To the extent possible, use a diversified approach toward weed management. Whenever possible
 incorporate multiple weed-control practices such as mechanical cultivation, biological management
 practices, and crop rotation.
- Plant into weed-free fields and keep fields as weed-free as possible.
- Identify weeds present in the field through scouting and field history and understand their biology.
 The weed-control program should consider all the weeds present. Apply this herbicide at the correct timing and rate needed to control the most difficult weed in the field.
- Fields with difficult to control weeds should be rotated to crops that allow the use of herbicides with alternative modes of action (MOA) or different management practices.
- Difficult to control weeds may require sequential applications of herbicides with differing MOA's.
- Prevent field-to-field and within-field movement of weed seed or vegetative propagules. Thoroughly clean plant residues from equipment before leaving fields.

APPLICATION DIRECTIONS

Apply uniformly with suitable, calibrated application equipment. The size and bulk density of granules in this product may vary; therefore, calibrate your granular applicator prior to application. A calibrated applicator must be used. Follow directions in the owner's manual for calibrating your applicator.

APPLICATION RATES

This product may be applied as a single application or in sequential applications to control weeds germinating throughout the year. All applications must be made prior to germination of the target weeds. This product will not control established weeds. The length of time of residual pre-emergence weed control provided by this product is related to the rate applied. Maximum use rate selection for turf should be based on turf species.

⁽¹⁾ In many areas a single application of 310 to 715 lbs. per acre will control Goosegrass. However, under heavy Goosegrass pressure and/or an extended growing season, most effective weed control may be obtained by making an initial application of 310 to 475 lbs. per acre followed after 60 to 90 days by a second application at doses that would not exceed those given in the Maximum Annual Application Rate section. Do not exceed the maximum rates in the Maximum Annual Application Rate section.

Sequential application may be made so long as the total amount of product applied does not exceed the maximum annual application rates. All applications must be made prior to germination of the weed seeds.

USE RESTRICTIONS

- Do not apply this product to putting greens, or areas where dichondra, colonial bentgrass, velvet bentgrass or annual bluegrass (poa annua) are desirable species

ESTABLISHED TURF

This product is a pre-emergence herbicide that, when properly applied, will control certain grass and broadleaf weeds listed in the Weeds Controlled Table in established turf grass and lawns. The maximum amount of material that may be applied per year is given for each turf grass species in the Maximum Annual Application Rate table. Most effective weed control in turf grasses will be obtained when this product is activated by at least ½ inch of rainfall or irrigation prior to weed seed germination and within 14 days following application. See the map for approximate crabgrass seed germination dates.

⁽²⁾ May be used on newly-sprigged or plugged bermudagrass at rates not to exceed 248 lbs. per acre. Newly-sprigged or plugged bermudagrass stolon rooting may be temporarily retarded. Suppression only of foxtail, goosegrass and rescuegrass due to reduced product rates used in sprigging situations. Do not apply more than 715 lbs. of this product_to the same area per calendar year. WHEN TO APPLY AFTER OVERSEEDING TURF

Delay seeding for 60 days after application or until after the second mowing, whichever is longer. Injury to desirable seedlings is likely if this product is applied before seedling secondary roots are in the second inch of soil, not thatch plus soil.

WHEN TO OVERSEED AFTER APPLICATION

This product will inhibit the germination of turf species if overseeded too soon after application. Follow rates and intervals in the table below for best overseeding and/or reseeding results.

LANDSCAPE ORNAMENTALS INCLUDING ESTABLISHED PERENNIALS AND WILDFLOWER PLANTINGS

This product may be applied for residual pre-emergence weed control around ornamentals and wildflowers listed on this label.

USE RATES

Apply at 310 to 715 lbs. per acre of landscape plants, in fall and /or spring. Use higher rates of application for longer control periods. Sequential applications may be made so long as the total amount of product applied does not exceed the maximum annual application rate of 715 lbs. per acre.

APPLICATION TIMING AND INFORMATION

Apply uniformly to the surface of the soil in ornamental planting beds with a granular applicator. This product is a pre-emergence herbicide and will not control emerged weeds. Most effective weed control in ornamentals will be obtained when this product is activated by at least ½ inches of rainfall or irrigation, or with shallow (1 to 2 inches) mechanical incorporation, prior to weed seed germination and within 14 days following application. Best weed control is obtained when this product is applied to soil free of clods, weeds, and debris such as leaves. Prior to application of this product, control existing vegetation by hand weeding, cultivation, or the use of an appropriate post-emergence herbicide.

ESTABLISHED LANSCAPE ORNAMENTALS

This product may be applied to established ornamentals as a broadcast, over the top, or directed application. Irrigation or rainfall soon after application will wash residues off plant foliage and activate this product into the soil.

NEWLY TRANSPLANTED ORNAMENTALS

This product may be applied to newly transplanted ornamentals as a broadcast, over the top, or directed application. Delay application to allow soil to settle around new transplants and water thoroughly before applying this product. Apply after cuttings from roots have become established. Apply before budding/grafting or after buds/grafts have taken to avoid any inhibition of the tissue union. Irrigate after application as above directed.

TOLERANT ORNAMENTAL SPECIES

This product will not harm most trees, shrubs, vines and flowers. The species listed below are tolerant to this product. Best results will be obtained when this product is uniformly applied to the soil surface; avoid applying to ornamental shoots which may defeat the effort to get uniform distribution on the soil surface. This product may be applied over the top of these species. When plants are under stress (such as heat, drought, or frost damage) some cultivars of listed plants may be sensitive to this product.
