GENERAL CLASSIFICATION**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Microbiocide 10 is used in recirculating commercial and industrial water cooling systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 6.0 Microbiocide 10 per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 2.0 to Microbiocide 10 per 1000 gallons every 1 to 5 days, or as needed. The frequency of additions should be made in the sump of water cooling systems.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Do not expose to extreme temperatures. Store in a cool, dry place. Drums should be opened in well-ventilated areas. Damaged drums should be placed in overpack drums and disposed of in a container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes are toxic. Do not reuse pesticide, spray mixture, or rinseate is a violation of Federal law.
