

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Microbiocide 100 is used to control bacteria and fungi in recirculating commercial and industrial air wash systems. To its use, systems must be cleaned to remove all slime, and other deposits. An initial slug addition of 100 fluid ounces of Microbiocide 100 per 1000 gallons of water to provide a concentration of 48 to 120 Microbiocide 100 based on the water volume in the system, is recommended. Repeat initial dosage should be made upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions may be made to collection trays of the airwash system.

Subsequent slug additions of 1.53 to 120 Microbiocide 100 per 1000 gallons of water should be employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions may be made to collection trays of the airwash system.

**STORAGE AND DISPOSAL**

Do not contaminate water, food, or feed by storage or disposal.

**STORAGE:** Do not stack more than four drums high. Leaking or damaged drums for disposal. Spills should be absorbed in sawdust or sand and disposed in a container closed when not in use.

**PESTICIDE DISPOSAL:** Wastes resulting from the use of this product should be disposed of in a approved waste disposal facility.

**CONTAINER DISPOSAL:**

- PLASTIC: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or for incineration, or, if allowed by state and local authorities, by other procedures approved by state and local authorities.
