Apply TPC Sevin 5% Dust when insects or their damage appear. Make applications in the morning or evening when it is cool. Treat upper and lower surfaces of foliage for complete coverage. Repeat as necessary, generally at 7 day intervals. Do not apply in excess.

FOR USE ON BEANS TO CONTROL:

MEXICAN BEAN BEETLE - Use at a rate of 1/4 lb. TPC Sevin 5% Dust per 1,000 sq. ft.

LEAFHOPPERS, BEAN LEAF BEETLE, CUCUMBER BEETLES, WESTERN BEAN CUTWORM, FLEA BEETLES, JAPANESE BEETLES - 1/2 lb. per 1000 sq. ft.

CORN EARWORM, ARMYWORMS, VELVET BEAN CATERPILLAR - 1/2 to 3/4 lb. per 1,000 sq. ft.

LIMA BEAN POT BORER, LYGUS and STINK BUGS - 1 lb. per 1,000 sq. ft.

May be used up to harvest. Apply thoroughly at first signs of insect infestation. When necessary repeat every 7 to 10 days.

FOR USE ON CUCUMBER, SUMMER SQUASH, PICKLES AND MELONS TO CONTROL:

CUCUMBER BEETLES, SQUASH BUGS, and FLEA BEETLES - 1/2 lb. per 1,000 sq. ft.

PICKLEWORM, MELONWORM - 1/4 TO 1/2 lb. per 1,000 sq. ft.

May be used up to harvest.


FOR USE ON GRAPES TO CONTROL:

GRAPE LEAF FOLDER - 1st brood: 1/2 lb. per 1,000 sq. ft. just before first brood larvae emerge from first rolls, 2nd and 3rd Broods - 1/2 to 1 lb. per 1,000 sq. ft.

GRAPE LEAF HOPPER - 1/2 lb. per 1,000 sq. ft.

May be applied up to 7-day preharvest.

FOR USE ON LETTUCE, MUSTARD GREENS, SPINACH, AND TURNIPS TO CONTROL:

FLEA BEETLES, HARLEGUIN BUG, LEAFHOPPER, - 3/4 to 1 lb per 1,000 sq. ft.

IMPORTANT: DO NOT APPLY TO HEAD LETTUCE WITHIN 3 DAYS OF HARVEST. DO NOT APPLY TO LEAF LETTUCE OR SPINACH, TURNIP OR MUSTARD GREENS WITHIN 14 DAYS OF HARVEST.

FOR USE ON DOGS AND CATS TO CONTROL:

TICKS AND FLEAS - Dust powder liberally over the entire body. Rub dust into hair and around feet, pads and between the toes so that they are well treated. Take care not to get the powder in the animals eyes, nose or mouth. Dust bedding, kennel and sleeping area regularly. Apply at least once weekly for best results. Do not use on Pregnant Dogs. Avoid treatment of kittens or puppies less than 4 weeks of age.

FOR USE ON CHICKENS, TURKEYS, DUCKS, GEESE, AND GAME BIRDS FOR CONTROL OF:

NORTHERN FOWL MITE, LICE and as a supplement to PREMISE treatment for CHICKEN MITES, and FLEAS - Dust birds at a rate of 1 lb. per 100 birds. As a litter treatment to control northern fowl mite, chicken mite, lice, fleas, and bed bugs, treat litter at a rate of 1 lb. per 40 sq. ft.

CAUTION: Do not repeat applications within 4 weeks. Do not apply to birds within 7 days of slaughter or do not house birds in treated houses within 7 days of slaughter. Do not apply directly to eggs or litter. Do not contaminate drinking water.
