DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

TPC EQUI-SPRAY "N" WIPE has been especially developed for use on horses. It gives a protective hair coating against flies while imparting a high sheen to the hair when brushed out. 1-2 ounces per animal applied daily gives adequate protection. Apply product with a soft cloth or as a fine mist.

TO WIPE ON

Make sure horses hair is free of dirt by brushing thoroughly before making application. Moisten a soft cloth with TPC EQUI-SPRAY "N" Wipe but not to dripping and rub over the hair paying special attention to the legs, shanks, shoulders, neck and areas around the face where flies generally are seen. It is best to apply by rubbing against the hair growth. Avoid using an excessive amount on animals. Do not wet skin. Brushing thoroughly after application will help bring out a sheen on hair coat. Repeat application daily or as needed.

USE AS A SPRAY:

EQUI-SPRAY "N" WIPE may be applied as a fine mist spray in and around stable area and stabled horses. Do not wet horse's skin nor use more than two ounces per application.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Storage: Store in a cool dry place.

Pesticide Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal (Plastic): Triple rinse (or equivalent), then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or, incinerate, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.
