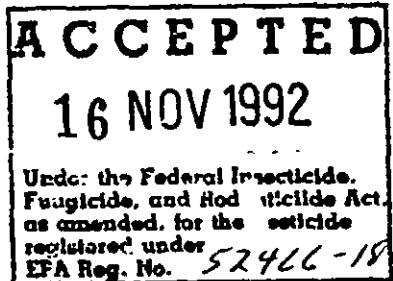

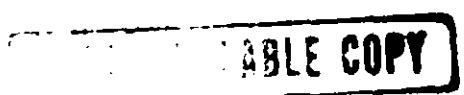

Before application remove dirt or debris by brushing or washing with a mild detergent.
