

An initial slug addition of Anchor - 105A fluid ounces of Anchor - 105A per 1000 gallons of water to provide a concentration of 32 parts per million of Anchor - 105A is recommended. Repeat initial dosage until control is achieved. Subsequent slug additions of 1.0 fluid ounces of Anchor - 105A per 1000 gallons of water should be employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions should be made in the summer months.
