DIRECTIONS FOR

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Pool-Aid

in swimming pools, exterior spas, whirlpools, hot tubs, and innumerable other pools, spas, whirlpools, hot tubs, and heavy growth of algae should be cleaned prior to using.

For pools having just visible algae growth add an initial dose of Pool-Aid

to move settled algae debris by cleaning. For treatment of a pool add initially 41 to 75 fluid ounces of Pool-Aid per 10,000 gallons of water. Subsequent additions of Pool-Aid per 10,000 gallons 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, and decorative fountains require an initial dose of 8 to 12 fluid ounces per 1000 gallons of water. For treatment of a freshly cleaned hot tub, or decorative fountain, add initially 4

Pool-Aid per 1,000 gallons. Subsequent additions of 1 to 3 fluid ounces of Pool-Aid should be made every 5 to 7 days after initial treatment.

Pool-Aid is compatible with chlorine. It can be used to treat pools, spas, and decorative fountains with an alkaline pH. Pool-Aid

is compatible with decorative fountains treated with chlorine chemicals and other chemicals normally required. However, do not mix Pool-Aid with concentrated dry or liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Containers should be placed in a plastic bag and disposed of with clear water. All pesticides should be kept out of the way from food.

DISPOSAL: Do not reuse empty container. Wipe out container.
