

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Pro-Tower is used to control bacteria and fungi in recirculating commercial and industrial air wash systems. To its use, systems must be cleaned to remove slime, and other deposits. An initial slug addition of 48 fluid ounces of Pro-Tower per 1000 gallons of water to provide a concentration of 120 parts per million of Pro-Tower in the system, is recommended. Repeat initial dose of 1.53 to 1.53 Pro-Tower per 1000 gallons of water.

Subsequent slug additions of 1.53 to 1.53 Pro-Tower per 1000 gallons of water are recommended. Repeat initial dosage until control is effected. Frequency of addition depends upon the relative severity of the bacterial problem. Slug additions may be made to collection trays of the airwash system.

Pro-Tower is used to control bacteria and fungi in recirculating commercial and industrial air wash systems that maintain effective mist. To its use, systems should be cleaned to remove slime, and other deposits. An initial slug dose of 24.7 to 24.7 Pro-Tower per 1000 gallons of water should be employed each time. Repeat initial dosage until control is effected. Frequency of addition depends upon the relative severity of the bacterial problem. Slug additions may be made to collection trays of the airwash system.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not stack more than four drums high. Leaking or damaged drums for disposal. Spills should be absorbed in sand or earth and later closed when not in use.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product should be disposed of in a approved waste disposal facility.

CONTAINER DISPOSAL:

PLASTIC: Triple rinse (or equivalent). Then offer for recycling or for secondary landfill, by incineration, or, if allowed by state and local officials.
